General Admissions Requirements

MedQuest College continually strives to maintain a student body that is committed to higher learning and career development. The Admissions department actively searches for students who have a yearning for postsecondary education within the healthcare field. Applicants who will be using Veterans benefits and who have attended another postsecondary institution must submit copies of all academic transcripts for consideration of previous credit prior to enrolling. All other applicants who wish to transfer previously earned credits must follow the transfer of credit policy.

TRANSFER OF CREDIT

Students transferring credits from other schools are required to earn at least 75% of the credits required CHANGE OF PROGRAM RE-ADMISSION PROGRAMS LEADING TO LICENSURE OR CERTIFICATION TRANSFER OF CREDIT 35 for completion of their program through instruction at MedQuest College. For credit from another institution to be considered for acceptance by MedQuest College, a minimum grade of "C" must have been achieved, and the course being reviewed for transfer of credit must have been completed within five (5) years from the beginning of first-term classes.

A determination will be made by MedQuest College as to the number of credits that can be transferred as credit toward the program requirements. This determination will be made in view of the course material previously taken and the length of time since the course was completed.

To have credits received at a previous institution considered for transfer, the applicant must submit an official transcript no later than seven (7) days before the beginning of first-term classes. Syllabi and course outlines, though not required, may be helpful in the determination process. An unofficial transcript may be used for evaluation purposes only. An official transcript must be sent directly to MedQuest College by the previous school for review by the Director of Education or appointed official. Special circumstances may be reviewed on a case-by-case basis by the Campus Director or Director of Education. Students with approved transfer credit will be charged a pro-rated tuition amount for the transferred course(s).

Transferability of Credit to Other Institutions

MedQuest College - Lexington does not imply, promise, or guarantee transferability of its credits to any other institution. In the U. S. higher education system, transferability of credit is determined by the receiving institution taking into account such factors as course content, grades, accreditation and licensing. This program is designed to lead directly to employment. Course credits will likely not transfer to other schools, and degrees will likely not be accepted by another school's graduate degree program.

Additionally, programs offered by one school within the MedQuest College system may be similar to but not identical to programs offered at another school within the system. This is due to differences imposed by state law, use of different instructional models, and local employer needs. Therefore, if a student decides to transfer to another school within the MedQuest College system, not all of the credits earned in this program may be transferable into that school's program. If a student is considering transferring to either another MedQuest College or an unaffiliated school, it is the student's responsibility to determine whether that school will accept the MedQuest College credits.
